"Carnage" seems like a pretty good descriptor. In Chicago alone in 2016, 24 children under the age of twelve, overwhelmingly black, were shot.

Trump has regularly denounced inner-city violence; he promised in his inaugural that that violence "stops right here and stops right now." He invoked the "child... born in the urban sprawl of Detroit" or in the "windswept plains of Nebraska" as both looking up "at the same night sky" and deserving of the same public safety. President Obama scoffed at Trump's concern over rising urban violence even as he regularly accused the

cops of lethally discriminating against blacks. For truth-telling when it comes to the actual dangers in American society, I'll take the current president over the former one and the cultural milieu from which he emerged.

## **The Ferguson Effect lives on: Violence in American cities rose again in 2016, as cops backed off proactive policing**

The Black Lives Matter crusade against the police continued to cost lives and destroy civil peace in 2016. Two recent estimates of violent crime in the nation's largest cities show that murders and shootings remained on an upward trajectory this year, as officers backed off of proactive policing. The **Brennan Center for Justice projects** [click the bold letters for background info] that murders in the 30 largest cities will be 14 percent higher in 2016 compared with 2015, a stunning increase coming as it does on top of 2015's already massive **homicide rise**, which was 14.5 percent in all cities with populations over 250,000 and 20 percent in cities with populations from 500,000 to 1 million. *The Wall Street Journal* **found** that homicides increased in 16 of the 20 largest police departments in 2016. Meanwhile, gun murders of police officers are up 68 percent through December 23, compared with the same period in 2015.

Medium-sized cities that don't show up in the Brennan Center or *Wall Street Journal* analyses are also in distress. Cleveland's murder numbers, for example, are up again in **2016 over 2015**, which, with a 15 percent spike over 2014, was already one of the deadliest years in a decade. By early December 2016, **Richmond had logged** a 40 percent increase in homicides over 2015, making this year Richmond's deadliest in a decade. And even in some cities where homicides decreased modestly over the previous year's violent crime surge, the drop may simply reflect the vagaries of emergency-room treatment, ambulance speeds and gangbangers' shooting skills. Non-fatal shootings are **up in Baltimore**, though homicides are down slightly compared with 2015. Measured on a per capita basis, 2016 will still be Baltimore's second deadliest year in its history.

The media, academia, and some police officials are again twisting themselves into knots to deny that depolicing is responsible for the ongoing violent-crime increase.

None of their alternative explanations fits the timing. [...] The strong version of what I have called the **Ferguson Effect** – a drop in proactive policing leading to rising crime – is the only explanation for the crime increase that matches the data. The country has just elected a new president who **understands that the false narrative about the police** has led to the breakdown of law and order in inner cities. If the crime situation improves in the coming year, it will be because Black Lives Matter calumnies no longer have an echo chamber in the White House and because cops on the beat believe that they will now be supported for trying to restore order where **informal social control has broken down**.

Dear Vice President Lee,

I am writing to express my outrage at the way in which Prof. Lisa Durden was treated today by the Essex County College administration. She was removed from her class and summarily taken to a meeting with Human Resources and yourself. Why was she not afforded union representation or the opportunity to call her union representative prior to the meeting?

During the meeting it is my understanding that the school suspended her for her alleged conduct on a Fox News TV show that she regularly appears on as a commentator. I have viewed her appearance on the show (<http://insider.foxnews.com/2017/06/06/black-lives-matter-black-only-memorial-day-picnic-tucker-carlson-lisa-durden>) and do not understand why this would cause her to be suspended.

Prof. Durden used no derogatory language in addressing the host (unlike the host who called her a 'Nazi'); she did not insult the host (while he called her 'demented, crazy and hostile'). She did not express any views that would incite violence or cause harm. Her argument was simply that Black Lives Matter organizers had a right to have a Memorial Day event for Black people, especially given the history of the holiday in the struggle against slavery and for African American liberation, which she explained succinctly and cogently.

There remains a little over a week left in the semester. If she is suspended, that means she essentially is fired as the investigation will no doubt take longer than this. I asked Prof. Durden to teach a Mass Communications class in the Fall and Prof. Elborj approved her to teach two English courses. I'm finalizing my Fall schedule and I need to know, will she be rehired in the Fall?

Prof. Durden has done amazing work for Essex County College for over a decade without ever getting paid. She has secured Communications students coveted internships in New York media with top documentary producers and organizations such as Byron Hurt, Black Public Media and the National Black Programming Consortium. Many of these interns were then hired in paid positions due to Prof. Durden. She worked with the Scribe Video Center in Philadelphia to bring the Muslim Voices media project to the Communications Program at Essex County College. She invited Essex County College Communications students to participate in and film the ImageNation Awards at the SVA Theater in New York that honored filmmaker Ava DuVernay.

She has spoken at numerous panels and Humanities Division conferences, all free of charge. Since becoming a professor at Essex County College teaching the Mass Communications and Popular Culture class, I have received nothing but effusively positive feedback from students about her teaching. In fact, I have received inquiries from community members asking how they could take her classes Fall semester. Prof. Durden brings real world media experience to the classroom. She has been recognized by her peers in the media industry, as well as being recognized by Seton Hall University, her alma mater and others.

I find it shocking that an African American woman would be so disrespected at her place of employment for merely exercising her First Amendment right to free speech.

In today's world, it is acceptable for the President of the United States of America to promote rape culture and say he will "grab 'em by their pussy" but a female public intellectual and media commentator cannot practice her First Amendment right, for if she does she is fired by a Predominantly Black Institution. As a white person, I was not at all offended by what Prof. Durden said. As a woman, I am horrified at this college silencing a woman's voice.

What kind of message are we sending to our students that it is permissible to verbally express violence against women but it is a fireable offense for a woman to express her opinion in a public forum? That we shouldn't speak out against racism and sexism? That it's OK for a white man to verbally insult and call a Black woman names but it's not OK for her to defend herself verbally? Is this really the message we want to send to our students?

I stand by Prof. Lisa Durden's First Amendment right to Free Speech and I welcome her to teach at Essex County College in the Fall. I am demanding that her suspension be lifted.


