DETAILS:

On 05/07/19 at 0059Hrs, MPO Gutierrez and Sgt. Stine responded to Caroline Hall for a hate/bias incident. They met with RA [REDACTED] and RA [REDACTED] whom stated that students [REDACTED] and [REDACTED] walked in to the lounge area to talk to a friend when they noticed several males playing a video game and a comment "Too many Jews to kill" was on the TV screen.

The players are all UMD students: [REDACTED]
[REDACTED] and [REDACTED]. The game "Whiplash" as explained, is: a prompt shows up on the screen and the players write an answer/comment individually, then all players agree on best answer. The prompt on this incident was a hot air balloon with binoculars on it and the comment "of I see....." Initially no one wanted to admit who wrote the comment, so MPO Gutierrez spoke to each individual student as to save face. Each student and their user id and their response is as noted:
