**NARRATIVE**

On December 17, 2021, at 0957 hours, I observed a female, identified as Daniela [REDACTED], standing on the GA400NB Windward Pkwy off Ramp, holding a sign, and asking for money. I got out of my vehicle and approached her. As I was approaching, she accepted some cash from a passing motorist who stopped and gave her some money. I had to walk directly onto the roadway to speak with her and escort her off the roadway. Daniela was wearing a brown jacket, a black and white dress and blue Hijab. I asked Daniela for her driver's license or any form of identification and she gave me a Romanian ID. She stated she does not have an ID or driver's license in the United States and that she is homeless.

Earlier in the day, Ofc. Foster stopped a panhandler on the GA400NB Mansell Rd Off Ramp and the description matched what Daniela was wearing. He also informed dispatch the person he was out with only had a Romanian ID. I contacted Ofc. Foster and asked if I was out with the same person he was earlier and he was able to confirm that it was by sending me a picture he had taken of the subject when he was out with her.

I am familiar with Daniela through other encounters I have had with her panhandling throughout the past year. I am unable to give any exact dates, but I personally have warned Daniela she is not allowed to panhandle in the city of Alpharetta approximately 2-3 times before this encounter. Daniela also admitted that Ofc. Foster did inform her she is not allowed to be panhandling when she was with him just an hour or so before speaking with me.

**Due to the multiple times she has been warned not to panhandle in the city** and the fact she was already warned by a different officer just an hour prior, **I placed her under arrest** for OCGA 40-6-97 Soliciting in the Roadway. Due to her cooperation, she was not placed in handcuffs. I released Daniela on a copy of charges with a court date of February 2, 2022 at 0900 hour at the Alpharetta Municipal City Court.
