The three films and 1 audio are short documentaries I made of interviews with four individuals describing their experience of reproductive healthcare including abortion care. The films themselves do not promote abortion. I would like to know which specific parts of the films you believe are in violation so that I can move forward in compliance with the law. The college has books about illegal drug use that are not necessarily endorsing illegal drug use. I am sure there are also books about abortion in the library too. It does not mean that the college is promoting abortion.
